

## QA and Validator Information for Florida Statewide Approvals (FSA's)

For Florida Approvals, the State of Florida requires you to have a third party validator as well as a third party Quality Assurance entity. Please see below for explanations and instructions for each, and please let us know if you have any questions.

1. Validator – This is a third party engineer hired by you that validates all documents that we submit to the state website to ensure compliance with applicable standards.

You may choose any state-registered engineer to perform your validation. A few options our clients have used include:

To arrange services with the validator, we suggest sending an email to the validator with the products you need validated, and the deadline in which you need the validation(s) completed (deadline per below). Note: We can send this email to the validator of your choice and CC you if you would prefer. You would still need to arrange services with the validator separately.

- → Whomever you hire, please let us know, as we need to include who the validator is as part of the FSA application.
- 2. Quality Assurance entity QA entities monitor the production of the product to ensure the product meets the tested and approved specifications.
